Mr. Chairman, we are in plenary session to consider changing the name of the Humane Killing Working Group. We have two proposals on the floor. One put forward by Japan to call it the Whale Killing Working Group. There is a second proposal to call it the Working Group on Whale Killing Methods and Associated Welfare Issues. These are two proposals and we will vote on them in the order in which they were put forward so we will vote first now on the proposal put forward by Japan to call it the Whale Killing Working Group. In other words just to change the one word of humane to killing. Mr. Chairman, there were ten votes in favour, fifteen against with nine abstentions and so that

proposed change of name is not adopted. We move to the second proposal which is to call it the Working Group on Whale Killing Methods and Associated Welfare Issues. This is the proposal

However, Japan would not like to hide our objection that we would not accept this terminology of the naming of the Working Group but we would not necessarily, you know what, would like to see the voting be taking place that is as far as Japan's objection is clearly recorded we would not want to see the voting taking place.
