Update on progress in engaging other organisations

At IWC66 the Commission adopted a number of recommendations relevant to engagement with other organisations, including recommendations transmitted by the Conservation Committee and Scientific Committee. The Secretariat is working with the Chair and Vice-Chair of the Conservation Committee, Standing Working Groups and other IWC experts as required to take forward these recommendations and to be proactive in identifying and communicating opportunities for strengthening engagement. This paper provides an update on implementation of these IWC recommendations, and suggestions on next steps. In addition, it discusses how the Secretariat and Conservation Committee could work together more closely on engaging other organisations, and recommendations that could be put to IWC67.

1. Review of implementation

Table 1. provides an overview of progress with implementation of recommendations for engaging other organisations endorsed by the Commission at IWC66 and relevant to the Conservation Committee agenda. A further report on progress will be provided to the Conservation Committee at that meeting.

2. Highlights and further opportunities

The summary below provides some further information on highlights and proposed next steps

Strengthened engagement with FAO and COFI on bycatch including participation in the FAO technical consultation on gear marking, and participation by the Chair of the Conservation Committee, Bycatch Coordinator and other members of the IWC Community in the recent FAO workshop on marine mammal bycatch.

Next steps: (i) Secretariat participation in FAO Committee on Fisheries (COFI) meeting in July 2018 including with a proposed side event on bycatch (ii) Engagement in FAO follow up to the marine mammal bycatch workshop.

Engagement in the Sustainable Development Goals (SGDs) process: The Secretariat attended the UN Conference to Support the Implementation of Sustainable Development Goal 14: Conserve and sustainably use the oceans, seas and marine resources for sustainable development (the UN Oceans Conference) in New York from 5 to 9 June 2017, to promote the IWC contribution to this SDG and to engage in relevant discussions. Several interventions were made including a plenary intervention highlighting the issue of Bycatch. In addition, the IWC submitted Voluntary Commitments to the Conference (<u>https://oceanconference.un.org/commitments/</u>) on Bycatch, Entanglement, Whale Watching and an overarching commitment on the Conservation and Management of Cetaceans.

Engagement with UNCLOS: The Secretariat submitted a contribution to the report of the UN Secretary General on Anthropogenic Underwater noise to the Open Ended Informal Consultative

Group on Oceans and Law of the Sea which will focus on Anthropogenic Underwater noise at its meeting on 18-22 June 2018.

Next steps: Given that the Secretariat can not prioritise attendance at this meeting it would be very grateful for any Contracting Members or observers who will attend to report back from the meeting, including on recommendations and opportunities for the IWC and Conservation Committee to help take these forward.

Continued engagement with IMO in cooperation with the Scientific Committee, including the provision of a paper to the IMO Marine Environment Protection Committee, providing an update of recent information related to the extent and impacts of underwater noise from shipping. The Secretariat and the convenor of HIM met with the IMO Secretariat in the margins of the MEPC to discuss the opportunities for further cooperation.

Next steps: (i) Continue engagement with the IMO on noise and, where appropriate, contribute to discussions on the inclusion of this topic in the work plan of the MEPC (ii) Continue engagement on the issue of ship strikes and, working with SC experts, engage in any relevant re-routing proposals (iii) engage in any other issues of mutual interest such as marine debris and voyage planning.

*Liaison Group of the Biodiversity-related Conventions*¹. The IWC Secretariat joined this group in October 2018 but has not yet had the opportunity to attend a meeting

Next steps: (i) Executive Secretary to attend meeting of BLG at the next opportunity (ii) Secretariat to attend the forthcoming CBD Conference of Parties in November 2018 (iii) To further consider and take forward opportunities to cooperate with BLG members.

Continued collaboration with CMS- Including Secretariat participation at the CMS COP12 in October 2017 and contribution to the development of CMS Resolutions in several areas and joint delivery of the Whale Watching Handbook

Next steps: (i) Continued collaboration with the CMS on the Whale Watching Handbook (ii) Collaboration on the development of a Conservation Management Plan for the Arabian Sea Humpback Whale (iii) Collaboration on other areas of mutual interest, including bycatch and strandings.

Work towards strengthening engagement with RFMOs – including discussions between the IWC and IOTC, ICCAT and IATTC Executive Secretaries and bycatch coordinator on opportunities to collaborate on this issue.

Next steps: Executive Secretary and bycatch coordinator to attend the Regional Secretariat Network (RSN) meeting (in advance of and following the COFI meeting) and to make a presentation on bycatch issues, to discuss opportunities for IWC and RFMOs to work together.

Ongoing collaboration with ASCOBANS and ACCOBAMS on a range of issues of mutual interest. The Bycatch Coordinator and Head of Science will participate in the joint ASCOBANS/ACCOBAMS working group on bycatch and ASCOBANS and ACCOBAMS are participating in the IWC Standing Working Group on Bycatch and Strandings Steering Group. Potential is being explored for a joint CMP with ACCOBAMS for the Mediterranean Fin Whale.

Next steps: (i) Continue discussions on joint CMP with ACCOBAMS for the Mediterranean Fin Whale (ii) further consider opportunities to develop collaborative projects on bycatch and strandings priorities, including joint fundraising.

Discussions with UNEP including ongoing work with UNEP-CEP to develop an MOU (following request of Parties to the Cartagena Protocol and UNEP-SPAW and endorsement of proposal to develop an MOU at the last Commission meeting. Unfortunately, UNEP requirements have revealed some MOU clauses that the Secretariat (following consultation with the Bureau) is unable to agree intersessionally and that will require Commission approval.

The Secretariat has also begun discussions with UNEP regarding opportunities for meeting with them in the margins of the next Scientific Committee meeting in Kenya.

Next steps: (i) MOU to be forwarded for Commission endorsement at its next meeting (ii) continue exploring opportunities to collaborate with UNEP, including through a meeting in Nairobi if possible

Collaboration with the IORA Secretariat and Australia in the establishment of the Sustainable Whale and Dolphin Watching Tourism Network.

Next steps: Collaboration with the Network through provision of information to the newsletters, dissemination of the IWC Whale Watching Handbook, and as opportunities arise.

2. Role of the Conservation Committee

There has been a growing number of IWC recommendations relating to engagement with other organisations. While the Secretariat tries to take forward these recommendations as far as possible, Secretariat resources (time and funding) to do so are limited and require a high degree of prioritisation e.g. which meetings to attend and the need for expectations management of potential partners.

The Conservation Committee Planning Group may wish to consider how the Secretariat and Conservation Committee can work more closely together in engaging other organisations to strengthen implementation of these recommendations. This could include:

- Conservation Committee advising on priorities to help guide the Secretariat work plan
- Action by Contracting Member through a) attending meetings of priority IGOs and reporting back from meetings when the Secretariat is unable to attend and b) liaison with the Secretariat (where attendance is a priority) to discuss details of participation in IGO meeting. This has already taken place for several meetings but could be strengthened. The Secretariat could support this by providing the Conservation Committee meetings with lists of forthcoming meetings, including those that the Secretariat plans to attend, and asking for volunteers to support participation.
- Action by Contracting Members to liaise with their counterparts in other IGOs to take forward IWC priorities and to speak in support (where possible) of IWC interventions at those meeting.
- This can be supported by ongoing review of implementation of relevant recommendations by the Conservation Committee, particularly when the database of IWC recommendations becomes operational, in order to identify where action is needed and how they can be taken forward.

If the CCPG agree with these suggestions then they could be developed for submission to the Conservation Committee.

The Secretariat had opportunity to meet again with the IMO Secretariat in the margins of the MEPC in 2017 and 2018 to continue these discussions.
