UK Visa Requirements

I thought it might be useful to provide guidance on visa requirements for entry to the UK well in advance of our Annual Meeting in London in July.

The table attached is based on information from the UK Foreign and Commonwealth Office web site, (www.fco.gov.uk) and provides the requirements *as of 14th February 2001*. It assumes that the purpose of entry to the UK is as a visitor (i.e. not for work or permanent residence), and that travel begins in the country of nationality and is direct to the UK (i.e. without stopovers in other countries which may have different visa requirements).

This information is provided as a guide, and I urge you to verify your own requirements. Appropriate local contact points are provided in the table.
