<u>Letter from the Chair of the Commission</u> Revision to the schedule of meetings for IWC/62, Agadir, Morocco

Further to Circular Communication IWC.CCG.853 of 12 March that included a schedule of meetings for Commission's sub-groups in the period 15 – 18 June and consultations this week with the Advisory Committee and Secretariat, and with the indulgence of Commissioners and Contracting Governments, I am proposing to revise the schedule of meetings for the Commission's sub-groups so as to make more time available for discussions on the future of the organisation prior to the plenary. This is the most important item on the Commission's agenda and I wish to make certain that we have sufficient time to discuss all issues of importance to member governments so that we are properly prepared for the plenary.

The revised schedule of meetings is shown on the following page. The scheduling of the Scientific Committee and Commission plenary meetings remain unchanged.

The revisions proposed involve the cancellation of the meetings of the Infractions Sub-committee and the Working Group on Whale Killing Methods and Associated Animal Welfare Issues. Reporting from governments and discussions on these matters will be done directly in the plenary. I have given very careful thought to these revisions and believe that given the agendas and workload of the different groups, this is the most efficient way to proceed. I must stress that cancelling the meetings of the Infractions Sub-committee and the Working Group on Whale Killing Methods and Associated Animal Welfare Issues should by no means be seen as implying that the work of these groups is not important. Be assured that I shall make sure that adequate time is allocated in plenary to addressing these issues.

I look forward to seeing you all in a few weeks time.
