Whale Killing Methods and Associated Welfare Issues Sub-Committee (WKM&AWI)

The WKM&AWI Sub-Committee will hear the reports of the following IWC workshops:

- i. IWC workshop on the effective welfare management of live stranded cetaceans: improving networks and guidance for euthanasia. This workshop will be held in late 2013 at the Institute of Zoology in London, United Kingdom. Invitations will be sent from the Secretariat to all IWC Contracting Parties by April 2013.
- ii. A large whale entanglement response training workshop for Spanish speaking countries in the Wider Caribbean Region. This workshop was held 27-29 November 2012 at La Paz, Mexico.
- iii. A large whale entanglement response training workshop for French speaking countries in the Wider Caribbean Region. This workshop is planned to take place during 2013 and further details will be available shortly.

(At IWC/64 in 2012 the Commission also approved a proposal from the WKM&AWI Sub-committee for an interdisciplinary ship strike workshop in the wider Caribbean region. The report of this workshop will be heard by the Conservation Committee).


The full Scientific Committee continues to meet annually and the next meeting will be held in Korea in June 2013. The Committee operates 13 Sub-groups. Each Sub-group's workplan is described in the relevant section of the Scientific Committee's report.

The Sub-groups are:

- i. The Sub-committee on the Revised Management Procedure (RMP), including the Working Group on the Implementation Review of North Pacific Common Minke whales (NPM).
- ii. The Standing Working Group on Aboriginal Whaling Management Procedure (AWMP)
- iii. The Sub-committee on Bowhead, right and gray whales (BRG)
- iv. The Sub-committee on In-depth assessment (IA)
- v. The Working Group on Bycatch and other human-induced mortality (BC)
- vi. The Working Group on Stock definition (SD)
- vii. The Working Group on DNA
- viii. The Standing Working Group on Environmental concerns (E)
- ix. The Working Group on Ecosystem modelling (EM)
- x. The Sub-committee on Southern Hemisphere whales other than Antarctic minke whales (SH)
- xi. The Sub-committee on Small cetaceans (SM)
- xii. The Sub-committee on Whalewatching (WW)
- xiii. Special Permits (SP)

In addition to these Sub-groups the Scientific Committee receives reports of work undertaken (1) through the Southern Ocean Research Partnership (SORP); (2) through the IWC voluntary fund for small cetacean conservation research and (3) through the expert panel approach agreed for special permit reviews.

The Scientific Committee will hold a number of intersessional workshops (additional to the Commission workshops listed above) whose reports will be considered at the Committee's Annual Meeting. In the 2012-2013 intersessional period these include workshops on RMP Implementations and related matters including stock structure, AWMP development, and the POWER cruise programme (North Pacific Ocean Whale and Ecosystem Research).
