## Arrangements for the Scientific Committee Meeting, 22 April-3 May 2024 and associated meetings

The next Annual Meeting of the IWC Scientific Committee (SC69B) will take place in person, from Monday 22 April – Friday 3 May 2024, at the Hotel Rikli Balance, Bled, Slovenia. Monday 22 April will be dedicated to Plenary sessions. Sub-committees will meet from Tuesday 23 April – Monday 29 April. Tuesday 30 April will be for compiling reports. The final three days (Wednesday 1 May – Friday 3 May) will be used for Plenary business.

#### **Visas**
