1. Background


1.1. Financial Regulation E.4. requires the Executive Secretary to report to the Commission the position regarding the collection of annual payments. This report fulfils that requirement.

2. Collection Rate of Contributions 2017 & 2018 to date

- 2.1. Graphs 1 and 2 below detail the pattern of contribution receipts for the 2017 financial year and 2018 financial year (to 31 July 2018).
- 2.2. Each graph shows the total amounts received in each month and the cumulative total of receipts for the year. The grey line indicates the total amount of contributions due from contracting members and the red line indicates the due date for contributions.

In accordance with Rule of Procedure E.2a and Financial Regulation F.2, if these Governments remain in arrears the day before the plenary session commences (9th September 2018) their vote will be suspended. Vote suspensions will be confirmed via Circular communication on this date. The Annex to this report will be revised daily as necessary during the Plenary week of IWC 67.

¹ Financial regulation F.5 applies to Contracting Governments in arrears of 3+ years of contributions.
